#### **Objective**


The Fund aims to achieve long-term capital growth by investing primarily in equity securities of large cap global companies located throughout the world.

#### **Investment Strategy**



The Sub-Investment Manager's investment process seeks companies that are industry leaders who are viewed as innovators in their field with business strategies aimed at building on opportunities that have sustainable competitive advantages leading to the outperformance of competitors; corporate cultures emphasizing strong, quality and experienced management, with cultures that help to foster these attributes at management level; low or no debt; and attractive relative valuations.
