**OBJECTIVES AND INVESTMENT POLICY**

**Objective**

The investment objective of the Fund is to achieve long-term capital growth.

**Investment Policy**

The Fund will invest primarily in U.S. small capitalization equities which the Sub-Investment Manager defines as being within the same market capitalization range as those included in the Russell 2000 Growth Total Return Index (positions may include mid and large cap stocks).

The Fund seeks to achieve its investment objective by applying a bottom-up fundamental research strategy to select long and/or short positions in equities issued by companies across all industry sectors. For the avoidance of doubt, any short exposure will only be achieved synthetically (i.e. through the use of FDIs). The Fund may sell securities short as appropriate for speculative purposes.

The Fund is actively managed which means that the Sub-Investment Manager is actively making investment decisions for the Fund. The Fund is not managed by reference to any benchmark.

**Dividend Income**

Dividend Income that the Fund receives is automatically reinvested in to the Fund and is thus part of the share value.

**Investment Period**

The Fund is suitable for investors seeking capital growth over a medium to long-term horizon who are prepared to accept a medium to high level of volatility from time to time. The Fund is not designed for investors needing current income.

Subscription and redemptions of the shares can be carried out by 14:00 hours Ireland time on all Irish and United Kingdom business days and days on which the New York Stock Exchange is open for trading.

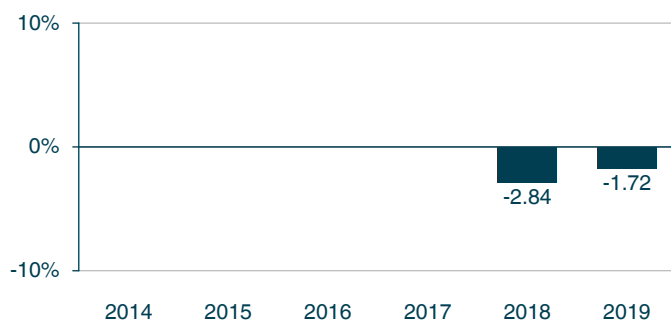
